

IMPORTANT 2024 TAX NOTICE FOR U.S. SHAREHOLDERS

This statement is provided for shareholders of P2 Gold Inc. (“P2 Gold”) who are United States persons for purposes of the U.S. Internal Revenue Code of 1986 (“the Code”), as amended and the regulations thereunder and are required to file a United States income tax return. It is not relevant to other shareholders.

P2 Gold is, more likely than not, considered to be a passive foreign investment company (“PFIC”) under § 1297(a) of the United States Internal Revenue Code for its taxable year beginning January 1, 2024 and ended December 31, 2024. The determination as to whether any corporation was or will be a PFIC for a particular year depends, in part, on the application of complex U.S. federal income tax statutes, regulations, and the interpretation thereof. In addition, whether any corporation will be a PFIC for any tax year depends on its assets and income over the course of such tax year and as a result, the PFIC status of P2 Gold for 2024 and any future year is subject to a complex analysis and therefore cannot be predicated with certainty. For P2 Gold’s shareholders that are subject to U.S. federal income tax, certain significant and potentially adverse United States federal income tax consequences result from this designation. These consequences may generally be mitigated by making a timely and effective election to treat P2 Gold as a Qualified Electing Fund under §1295 of the Code (a “QEF Election”).

Pursuant to the requirements of Treasury Regulation §1.1295-1(g)(1), the attached PFIC Annual Information Statement is being made available to U.S. shareholders who have made or intend to make a QEF Election. The attached PFIC Annual Information Statement contains information to enable you or your tax advisor to prepare your tax return if you make the QEF Election.

A U.S. shareholder who makes a QEF Election is required to annually include in income their pro rata share of the ordinary earnings and net capital gain of P2 Gold. The QEF Election is made by completing and attaching Information Return by a Shareholder of a Passive Foreign Investment Company or Qualified Electing Fund (Form 8621) to your timely-filed federal income tax return.

P2 GOLD IS UNABLE TO GIVE ADVICE IN THIS REGARD.
